Speaker:

Dwight Moulin, MD



Dwight Moulin is a Professor in the Department of Clinical Neurological Sciences and Oncology at Western University. He is also the former Earl Russell Chair of the Western Pain Program (2005-2020). He has published extensively on the role of opioid analgesics in the management of chronic pain and recently has led a series of observational studies on the long term outcome of the management of neuropathic pain. He has also done studies on medical cannabis for pain management. He chaired the Neuropathic Pain Special Interest Group of the Canadian Pain Society from 2005-2014 and led the Consensus Statement on the Pharmacological Management of Chronic Neuropathic Pain - initially published in 2007 and updated in 2014. He is a recipient of the Distinguished Career Award from the Canadian Pain Society and he is also a Founding Member of Pain Medicine as a new subspecialty of the Royal College of Physicians and Surgeons of Canada.
